

ABOUT THE ARTIST:

After working as a graphic designer and art director, Peggi Habets returned to her hometown of Pittsburgh to pursue her creative roots of drawing and painting. She found her niche in contemporary, figurative watercolor and has developed a thriving art business.

Influenced by her Italian/Slovak immigrant background, she gravitates towards ordinary, hardworking people as subjects for her paintings because “they have stories to tell”. These narrative paintings balance realism and ambiguity to add interest for the viewer.

She is currently working on a series about dancers in which she explores mixed media, abstraction, color, and gesture to create the right mood. She is drawn to the hard work and struggle of the dancers, as opposed to traditional “beautiful dancer” paintings.

Peggi has written a book titled “Watercolor Made Easy: Portraits”. She has been published in many high-profile art magazines, won numerous national and international awards, and has been invited to teach watercolor workshops around the country.

ABOUT THE 5 DAY WORKSHOP:

Students go beyond mere portraiture and the goal of achieving a likeness. We will delve into the design and planning that are integral in telling a story or communicating an idea.

The workshop will cover all stages of a painting, from initial inspiration and reference material, to value and color studies, to final painting of the figure(s).

Students may complete one or several paintings during the workshop, but the goal is to experiment with new ideas and techniques and make plenty of mistakes.
