

# RICHARD STEPHENS

A native of Hot Springs, Arkansas, **Richard Stephens** earned a Bachelor's Degree in Art from the University of Central Arkansas. After serving in the Army as an illustrator, he began his professional career with a design firm in Little Rock, Arkansas. Three years later he opened his own graphic design studio in his hometown.

Richard rediscovered transparent watercolor in the early '90s. He quickly garnered a reputation for his confident, loose, impressionistic paintings. His works have won numerous awards and has been featured in numerous publications.

Although recognized for his landscape, architectural and figurative work Stephens feels the real subjects of most of his paintings are his brushwork and the light he tries to capture and amplify through value contrast and an unexpected color pallet. Richard states that through teaching, more than any other endeavor, he continues to learn.
